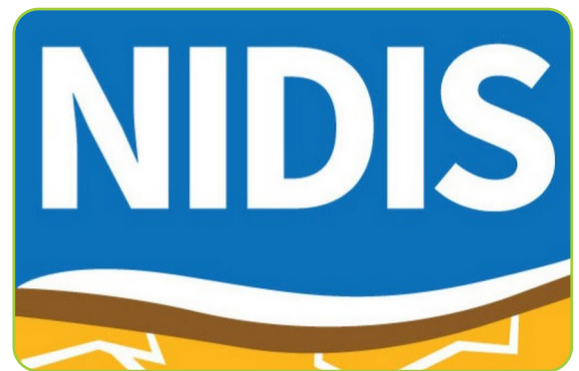




## DROUGHT

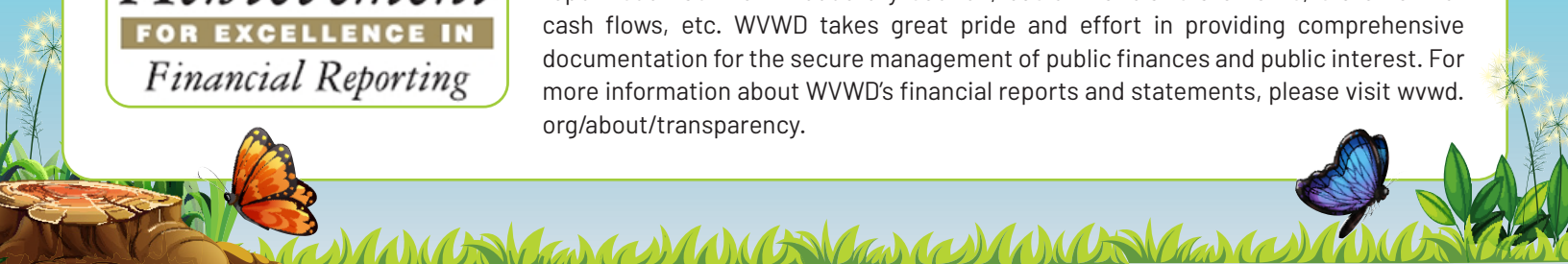
According to the U.S. National Integrated Drought Information System (USNIDIS), a multi-agency partnership that coordinates drought monitoring, forecasting, planning and information across the country, WVWD occupies an area undergoing severe drought. Despite this drought rating, WVWD is still better off than nearly half of California, which experiences exceptional drought or the most severe rating in the USNIDIS system. While WVWD has been spared the worst drought rating so far, reservoir levels remain low and a lack of adequate moisture is causing vegetative stress that may result in a higher risk of wildfires. Because the National Oceanic and Atmospheric Administration projects California's drought to last well into 2022 or potentially longer, WVWD implores all ratepayers to take significant steps to practice sustainability and reduce water consumption wherever possible. To help you switch to water-efficient irrigation systems, appliances, bathroom fixtures and other tools that can save you hundreds or thousands of dollars per year, we offer special rebates for items that can help you save more. ## CERTIFICATE OF EXCELLENCE IN FINANCIAL REPORTING

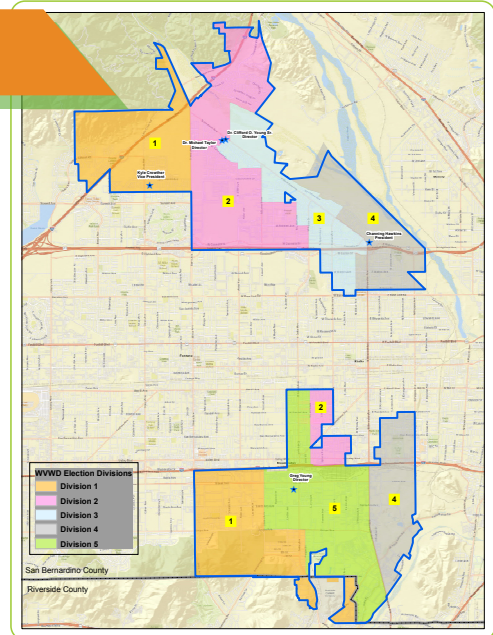


WVWD is proud to announce that we have earned the California Municipal Treasurer's Association (CMTA) Investment Policy Certification for adhering to best practices for our investment policies and the Government Finance Officers Association's (GFOA) Certificate of Achievement in Excellence in Financial Reporting for the tenth year in a row for maintaining high standards with our financial disclosures. To receive the CMTA award, we submitted our investment policies to the CMTA, who assigned three separate CMTA professionals to grade them on various topics including ethics policies, internal controls and reporting standards. Our cumulative investment policy score average was 98.67 out of 100 possible points, which we believe reflects our prudent investment decisions, clear ethics and transparency policies. The GFOA Certificate of Achievement involves a special review of our agency's comprehensive annual financial report (CAFR) and grades on several categories pertaining to the report such as the introductory section, basic financial statements, statement of cash flows, etc. WVWD takes great pride and effort in providing comprehensive documentation for the secure management of public finances and public interest. ## REDRAWING OUR ELECTORAL BOUNDARIES

As required by law, WVWD is conducting its decennial redistricting process. This law requires that we redraw our electoral boundaries for board directors based on 2020 census data to better reflect and represent local populations. To develop a plan, WVWD selected Lucien Partners, a top regulatory risk analysis and voter education firm with a reputation for exceptional transparency and public outreach. Over the next several days, WVWD will work with Lucien and conduct five public redistricting workshops to provide transparency on the redistricting process and ensure ratepayers' voices are heard.
